MOUNTAIN VIEW SUMMER CAMP (MVSC) PET POLICIES

Mountain View Summer Camp desires that its members enjoy their camping experience. This Policy will be enforced on the campgrounds for the safety and well-being of all campers. Pet owners should familiarize themselves with this Policy as they will be required to abide by it during their stay at Mountain View Summer Camp.

A) GENERAL PET POLICIES

1. All Pet owners must sign a Waiver and Indemnity form releasing the Conference and MVSC from liability and indemnifying the Conference for any and all damages that their pets may cause.
2. If, at MVSC's sole discretion, it concludes that a pet has caused or is likely to cause damage, harm, or disruption to property or other persons attending Camp, the owner will remove the pet from the Camp immediately.

B) PET POLICIES

1. All General Pet Policies apply to pet owners
2. No aggressive pets.
3. All pets must be kept on leash **while walking, or in a cage** at all times when outside RV's, cabins or tents
4. Pets are not allowed in or around:
 - Any building
 - Washrooms facility
 - Meeting places
 - Horse Corrals
 - Back trails
5. Owners must pick up after their pets at all times in all areas. You must bring your own "doggie" bags.
6. Dogs must be licensed.
7. You are responsible for cleaning the cabin/camping area of any evidence of your pet. This includes any shedding of hair.

PET AND HOLD HARMLESS AGREEMENT

THIS IS A LEGAL DOCUMENT. BY SIGNING THIS DOCUMENT, YOU ARE GIVING UP CERTAIN LEGAL RIGHTS INCLUDING THE RIGHT TO SUE. YOU ARE ALSO ASSUMING CERTAIN OBLIGATIONS.

In consideration of being allowed to bring my pet(s) to Mountain View Summer Camp and Retreat Centre, BC, (the "Camp") held and organized by the Seventh-day Adventist Church (British Columbia Conference) (the "Conference") I, the undersigned, do hereby agree as follows:

1. I have read and will abide by all policies of MVSC (BC Conference) related to pets (as such policies may be amended or adjusted by MVSC (the Conference). We reserve the right to change the Policy at any time. Your signature agrees to the adjusted policy when provided to you.
2. I will remove my pet from the Camp immediately upon request of MVSC Staff if, in MVSC's sole discretion, it concludes that my pet has caused or is likely to cause damage, harm, or disruption to property or other persons attending the Camp;
3. I waive, release and forever discharge MVSC (the Conference, its affiliates, members, directors, officers, leaders, agents, volunteers and/or employees (collectively the "Releasees") from all actions, causes of actions, suits, claims and demands whatsoever that I may have against any of them as a result of, arising out of or in any way connected with my pet(s) being at the Camp;
4. I will indemnify and hold harmless each of the Releasees and all of them from and against any and all actions, suits, expenses, damages, losses, expenses, claims or demands whatsoever (including legal fees on a solicitor and own client basis) that any of the Releasees may suffer or that may be brought, alleged or made against any of them by any third party, arising from, caused by, connected with or related to my pet(s) being at the Camp.
